Regional meeting to review the work of the Persistent Organic Pollutants Review Committee

Panama City, 17 February 2008

Preview

The Persistent Organic Pollutants Review Committee (POPRC) is a subsidiary body of the Stockholm Convention that is mandated to assess any proposal by a Party for a chemical to be listed as a POP in the Stockholm Convention. The POPRC comprises of thirty-one members including government-designated experts that are nominated from selected Parties from all UN regions. The POPRC meets annually and the meeting is open to observers. Both Parties and observers are invited to provide information and technical comments on the chemicals under review at all stages of the assessment. Currently, the POPRC is considering eleven chemicals. These are: Chlordecone, Hexabromobiphenyl, Lindane, Commercial pentabromodiphenyl ether, Perfluorooctane sulfonate (PFOS), Alpha-hexachlorocyclohexane, Beta-hexachlorocyclohexane, Commercial octabromodiphenyl ether, Pentachlorobenzene, Short-chained chlorinated paraffins and Endosulfan.
